



DOGGIE DAY CARE AGREEMENT

This agreement is entered into by and between Ortega Animal Care Center Doggie Day Care and the dog(s) Owner named at the bottom of this page.

Owner understands and agrees that Owner is solely responsible for any harm caused by Owner's dog(s) while Owner's dog(s) is/are attending Ortega Animal Care Center Doggie Day Care.

BEHAVIORAL REQUIREMENTS:

Doggie Day Care is designed to enhance your dog's social skills and provide a safe, fun environment that allows your dog to play and interact with other friendly dogs. Consequently, all dogs must be "dog friendly" and have never shown any aggressive behavior toward another dog. This includes food aggression. An evaluation will be conducted to help determine each dog's behavior before being admitted to the program.

HEALTH REQUIREMENTS:

Ortega Animal Care Center Doggie Day Care accepts dogs for participation with the understanding that the Owner's dog(s) are in good health. Dogs will not be admitted that do not appear to be in good health, are coughing, sneezing or with skin conditions (hair loss, lesions). All dogs must be on a flea control product (i.e. Frontline, Advantage). However, no guarantee of a "flea free" environment is made. If fleas are found on your pet you will be notified and have the option of purchasing a flea product from OACC.

VACCINE REQUIREMENTS:

In order to assure the safety of all dogs attending Doggie Day Care, all required vaccines must be kept current and proof of vaccination will be necessary before admittance. Ortega Animal Care Center Doggie Day Care requires the following vaccines prior to participation:

- DHCP-P: Vaccine given within the last year OR a titer test performed within the last year indicating adequate levels of antibodies in the blood.
- RABIES: Current pursuant to Orange County requirements
- BORDATELLA: Given within the last 6 months – minimum of 2 initial vaccines

PARASITE CONTROL:

To ensure that your pet is not carrying any parasites, a negative fecal exam is required every 6 months. You may provide records from your regular Veterinarian or have OACC perform the test at a discounted rate of \$35.00 on the day of check-in.

SPAY/NEUTER:

All dogs over 6 months of age must be spayed or neutered to participate in Doggie Day Care.

SCHEDULED PICK UP:

Owner understands and agrees if Owner's dog(s) is/are not picked up by 7PM, additional fees will be incurred. A fee of \$10.00 for pick-ups past 7:00 PM will be incurred and payable when your dog(s) are picked up. Furthermore, if the dog(s) are not picked up prior to the following business day, the dog(s) will be placed in the Pet Hotel Suites and boarding fees will be incurred.

FEEDING:

Please feed your dog before bringing him/her to Doggie Day Care. If your dog requires a meal while in daycare, please make prior arrangements. We do provide treats throughout the day so let us know if your dog has any food allergies we need to be aware of. Your dog will have played hard all day and will be ready for dinner when he/she arrives home.
